a. Finance Directors monthly report

- J. Marcotte stated the revenues recorded to date are \$34,795,302.93 or 101.32% of budgeted revenues. The expenditures recorded to date are \$33,856,354.82 or 98.59% of budgeted expenditures. J. Marcotte noted there are a few new line items overspent as well as several other overspent line items which have been previously discussed. J. Marcotte also stated there is an additional \$400,000 in revenues collected and \$200,000.00 less in expenditures. Therefore approximately \$600,000.00 will be going back to surplus.
- b. Discussion and possible action on Contingency Board of Education budget line item.
 - S. McKenna requested the approval to draw up to \$100,000.00 from the Town of

Griswold contingency fund in order to post and hire one additional Special Education teacher for the 2019-2020 school year. He stated at this time there are six confirmed students from sending towns. These six students will generate a total of \$148,488 in revenue for the Town of Griswold and will therefore reach the monetary breakeven point immediately. He stated once the teacher is hired, the Board of Education will provide the board of Finance with monthly reports as stipulated in the Town's Board of Education Tuition Policy. **MOTION:** S. Mikutel made a **motion** that was seconded by G. Rooke-Norman to transfer upon hire up to \$100,000.00 from the General Government budget account 7101 Emergency and Contingency code 5801 known as Contingency Board of Education to the Board of Education budget to hire and pay for teaching staff and fringe benefits to accommodate additional students in the Griswold High School Special Education program in accordance with the tuition revenue proposal distributed by the Board of Finance. All in Favor; **motion carried.**
