# BOARD OF WARDEN AND BURGESSES REGULAR MEETING APRIL 2, 2018

## **PLEDGE OF ALLEGIANCE**

#### **ROLL CALL:**

# APPROVE MINUTES OF THE REGULAR MEETING OF MARCH 5, 2018:

Burgess Sorder made motion to accept the meeting minutes of March 5, 2018 as presented, 2<sup>nd</sup> by Burgess Krueger. All in favor, aye. Motion carries. Laura Laidley abstained.

# **COMMISSIONER REPORTS:**

- FIRE—none
- BLIGHT Burgess Sorder noted that she spoke with Jack Cipriano, acting building inspector about the Mechanic Street property. Wondered if he was at the right property because he noted that it was safe and secure.
  Burgess Sorder will connect with him again regarding this property when she gets a call back from him.
- NUISANCE Burgess Laidley noted that people have asked her what the clean-up policy is since there have been trees in the roads. The highway dept. should handle this type of complaint.
- POLICE- Burgess Krueger deferred to Trooper Cote regarding the Wyre Wynd situation and Mechanic Street vehicles. Burgess Krueger did ask Trooper Cote about the cars parking on Main and Ashland Street. He has issued 1 ticket for that violation.

#### RESIDENT TROOPER REPORT:

Trooper Cote reported that he spoke with the owners of 135 North Main Street regarding the vehicles that are on the property. The owner said that he works on family members cars. He has 5-6 unregistered vehicles, he can have no more than 2. Trooper Cote gave him approx. 2 weeks to get everything cleaned up. Also, noted he cannot work on the cars at night time. # 1. Motion to re-adopt the Borough of Jewett City Fair Housing Resolution.

## 1. Housing code update.

# 2. Ethics Update

Burgess Sorder went to the Ethics Committee Meeting on the 29<sup>th</sup> of March and spoke with them about merging with them and being part of that committee. There were concerns about a borough employee which is not a town employee. Talked about someone from the borough being on the commission, adding language to the code saying Town of Griswold and Borough of Jewett City. Suggestion was to talk to the selectmen about this. Another option would be to have our own commission or to have a borough resident be part of the commission and make it joint. Burgess Sorder would like to have discussion with the selectmen and see what they feel.

Burgess Sharkey made motion to have Burgess Sorder meet with the Board of Selectmen regarding the Ethics Commission, 2<sup>nd</sup> by Burgess Krueger. All in favor, aye. Motion carries.

# ANY OTHER BUSINESS BEFORE THE BOARD:

Selectman Babbitt sent a message to the board asking permission to install a gate at the firehouse fence. He would like access to the playground, so a dump truck could get in and do maintenance ie. installing wood chips. There was discussion on this with the board. Lou. Demicco noted that he knows where it would be put and he has no problems as long as it is locked. Burgess Sharkey noted that it should be used for maintenance only and be locked at all times.
