1. Call to Order

Chairman C. Kinnie called the regular meeting of the Griswold Commission (IWWCC) to order at 7:30 p.m.

2. Roll Call & Quorum

Chairman C. Kinnie appointed Martin McKinney to sit for Gary Serdechny and noted that a quorum was present.

Chairman C. Kinnie read the following application into the meeting record and noted that the applicant's contractor stated at the December 16, 2021, Wetlands meeting that he could not be at tonight's meeting.

A. CC 15-2021 Jim Wray, 83 Burdick Lane, applicant desires to install a 25 ft. x 50 ft. inground pool within the Upland Review Area.

Chairman C. Kinnie reviewed the revised site plan that was amended by the applicant's contractor Steve. Chairman C. Kinnie noted that the following items have been added to the site plan as requested by the Commission:

- Silt Fence location
- Abutting property owners
- Well and Septic System locations on the abutting properties
- 80 cubic yards to be removed from the pool excavation
- No on-site material storage for excavated earth material

Chairman C. Kinnie stated that all required items have been added to the site plan.

Commissioner R. Parrette asked Town Planner Mario Tristany if he had reviewed the plan. Town Planner M. Tristany stated yes, and further noted that all the Commission required additions have been added to the site plan.

Chairman C. Kinnie asked for a motion on CC 15-2021.
