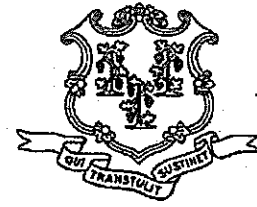

6. Any other business


